# REINEM-N-KENNELS

## **THE OWNER(S) OF THE BITCH AGREES TO:**

1. Provide the stud dog owner with:
  - a. 3 Generation pedigree
  - b. O.F.A. or Hip and Elbow x-ray evaluation
  - c. Health Tests - Eye Cerf, DM, MDR1, any other relevant DNA tests
  - d. Brucellosis test report (drawn at start of heat cycle prior to breeding)
  - e. AKC registration papers (or registration papers from your associated kennel club)
2. The bitch must be up to date on all vaccinations including rabies, distemper, parvo, and Bordetella. She also may not be ill at time of breeding to protect the health of all dogs present.
3. Bitch must be parasite free to include fleas, ticks, and roundworms. Additional charges may be incurred and the responsibility of the bitch owner for any parasitical infestations to our breeding location(s).
4. Keep the bitch confined while in heat and assures she is not bred with any other stud dog. Amis-mate breeding before or after stud service would cancel stud service agreement. Stud fee is non-refundable.
5. Notify the stud owner within 48 hours after the bitch whelps with photos of puppies, or within a week after due date if no litter is whelped.
6. Responsibility of transporting the bitch to the stud dog. If shipping your bitch, please ship in a minimum of a 400-size crate or comparable 24 X 42 size. Owner of the bitch is responsible for all expenses incurred including travel.
7. Supply food and any supplements needed for duration of breeding.
8. No puppies shall be sold in any pet stores, retail, or wholesale outlet, and to any illegal dog operations.
9. Additional veterinary costs for any artificial insemination or estrus testing will be passed on to the bitch owner. Bitch owner agrees to pay for any estrus testing should stud owner feel such testing is warranted because the bitch will not stand, the stud will not breed or cannot penetrate, or more than one bitch is being mated to the stud.
10. Notify stud dog owner of any hereditary or genetic problems that arise with the bitch or offspring.

## **IN RETURN THE STUD DOG OWNER AGREES TO:**

1. Provide the owner of the bitch with digital files for:
  - a. 3 Generation AKC Pedigree
  - b. OFA Hips, Elbows, DNA test results
  - c. Brucellosis test report (performed annually)
  - d. Any registration papers

2. Approved pictures for marketing purposes. Pictures are not to be used that are not pre-authorized by stud dog owner. A reference to our website for the stud dog is acceptable.
3. Keep the bitch confined while visiting the stud dog and assure that she is not bred with any other stud dog. If sending semen (fresh or frozen) it will be sent in a timely manner, given the stud dog owner has been given adequate amount of time to send collection.
4. Guarantee a minimum of two (2) live puppies. If the breeding results in less than two (2) puppies, naturally or AI, the same bitch may return for a breeding within 18 months of the date of signing this contract. If the same bitch is unavailable to be re-bred due to death, infertility (verified by repro vet), or due to age exceeding 7 years then a breeding may be transferred to another approved bitch (same information to be provided as above if transferring to another bitch) within the same 18-month puppy guarantee period. Stud Service deposit is non-refundable.
5. Sign any registration documents that are necessary for the registration of the litter (if all terms above have been satisfied).
6. Stud owners will take every reasonable precaution to ensure the safety and well-being of the bitch, but will not be held liable for any sickness, accident, injury, or death of said bitch while in the care of stud owner.
7. Notify the bitch owner of any hereditary or genetic problems that arise with the stud dog or offspring.
8. Breed the bitch a minimal of 2 times by live cover during time with stud dog owner.
9. **\*A boarding fee of \$20.00/night applies after three days with stud dog owner.**

## STUD FEE AND TERMS

- Stud fee is: **\$2500.00** Payments as follows: **\$1250.00** due at breeding, **\$1250.00** due at one week post birth date.
- Stud fee is due and payable upon breeding or shipment of semen. If stud fee is a pick puppy back, the decision will be made by 9 weeks of age. All puppies must be present, and no puppy is to be placed until stud dog owner has made his/her decision. The pick puppy will carry the kennel name of the stud dog owner(s) and will be owned solely by stud dog owner(s). Bitch owner(s) kennel name may be added with bitch owner(s) authorization by signing this agreement but at the discretion of the stud dog owner (s).
- No registration papers will be signed without payment in full of stud fees and all other related breeding expenses as detailed in the contract.
- All veterinary fees associated with collection(s) and shipping/transportation expenses are the responsibility of the bitch owner.
- All veterinary fees associated with collection(s) and shipping/transportation expenses are the responsibility of the bitch owner.
- We reserve the right to return the bitch unbred due to misrepresentation, lack of breed type and/or quality incompatible with our stud dog.
